VACANCY ANNOUNCEMENT

1.0 TABORA URBAN WATER SUPPLY AND SANITATION AUTHORITY(TUWASA)

Tabora Urban Water Supply and Sanitation Authority (TUWASA) is a semi-Autonomous water utility organization authorized to offer water supply and Sanitation services in Tabora Municipality. It is one of nineteen water supply and sanitation Authorities in Tanzania that were declared by the Minister of Water and Livestock Development on the 1st January 1998 through the powers vested in him by section 38 of the water works ordinance 1949 and Regulation 3 (1) of the water Regulations Published in the Government Notice No. 371 on the 25th July 1997.
